A Monthly Statistical Report on the Real Estate Investment Trust Industry

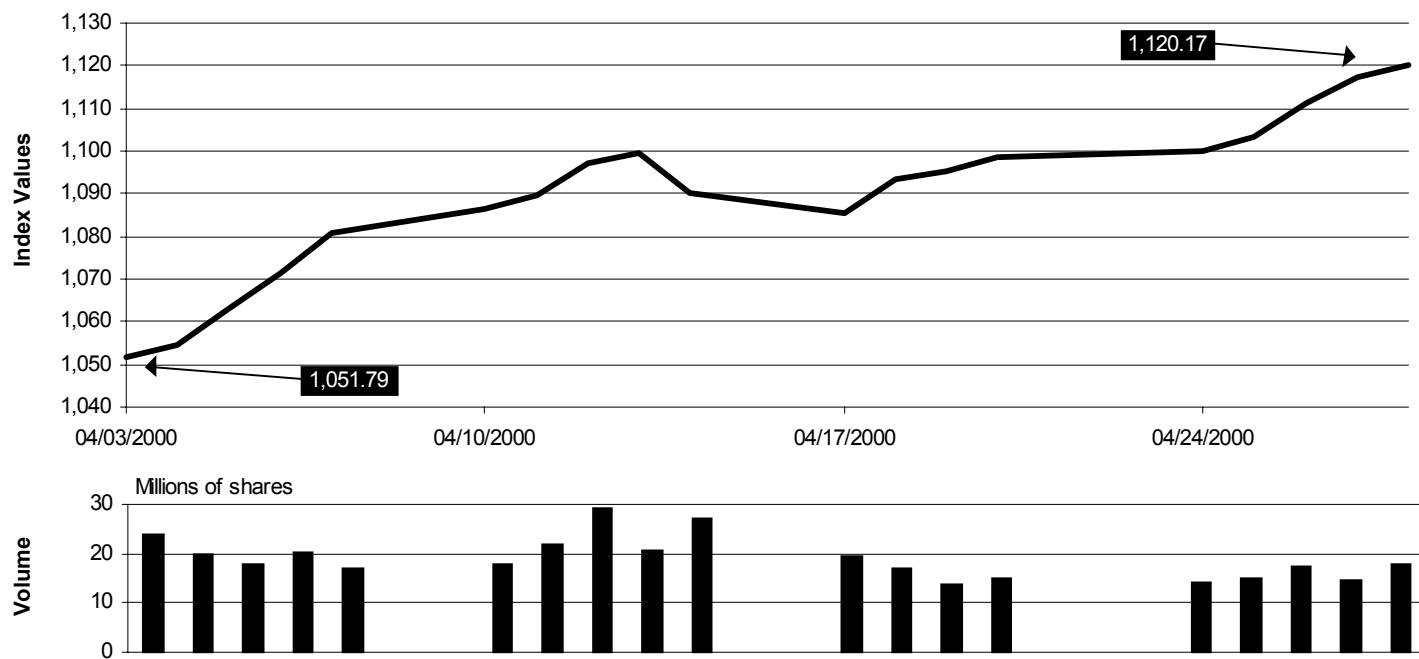
Performance Summary:

In recent months, the relative performance of different sectors of the equity market clearly has shifted. Although it remains unclear whether such a shift will prove to be only transitory or more lasting, evidence of such a shift is apparent in year-to-date returns. As shown in [Exhibit 8](#), the NAREIT Equity REIT Index through May 5 posted a total return of 12.3 percent, including a price appreciation component of 9.4 percent. Only the S&P Utilities Index recorded a larger advance, jumping 15.3 percent in price over the period. Year-to-date returns of all other major market indexes were more subdued as the outlook for inflation and Federal Reserve interest rate policy became more uncertain, and as investors appear finally to have become less comfortable with the valuations of at least some high-flying technology stocks. Since the

beginning of the year, the S&P 500 declined 2.5 percent, the NASDAQ Composite is down 6.2 percent, and the Dow Jones Industrials fell 8.0 percent (all without dividends reinvested). At the same time, the Russell 2000 rose 2.0 percent, including reinvested dividends. This increase owed entirely to a 5.2 percent rise in the Russell 2000 Value component, which in turn was driven by its more than 10 percent weighting in REIT stocks.

Since the REIT market bottomed on December 16, 1999, the comparisons are equally noteworthy. As shown in [Exhibit 9](#), from December 16 through May 5, the NASDAQ Composite rose 2.7 percent, the S&P 500 inched up 1.0 percent, and the Dow fell 5.9 percent. Over the same period, the Russell 2000 rose 10.7 percent, the S&P Utilities jumped 20.7 percent,

and the NAREIT Equity REIT Index soared 21.6 percent. Of course, REIT stocks also performed well just one year ago. From March 23 through May 13, 1999, the NAREIT Equity REIT Index posted a total return of 16.6 percent. However, last year's rally lasted only about six weeks, after which REIT stock prices weakened again for most of the remaining year. This year's upward move now is in its sixth month and, with first quarter earnings reports indicating that earnings growth may have stabilized, the current move may prove to be more durable.

Investment Correlations for REITs:

As REIT total returns have turned positive, even as other sector returns have weakened, investors once again have become interested in the relationships between REIT returns and those from other investment sectors in order to anticipate how REIT stocks might perform going forward if other sectors continue to falter. [Exhibit 10](#) summarizes the correlation coefficients of REIT returns with those of other sectors using monthly data over the past 10 years. The upper right part of the table shows correlation coefficients for the 5-year period beginning April 1990 and ending March 1995, while the bottom left section of the table shows correlation coefficients for the subsequent 5-year period beginning April 1995 and ending March 2000. Correlation coefficients are computed for REIT returns and a variety of other stock and bond indexes.

In both periods, the NAREIT Equity REIT Index was most highly correlated with the Russell 2000 Value Index, with a correlation coefficient of about 0.7 in both periods. In part, the relatively high

correlation of these two indexes owes to the fact that the Russell 2000 Value Index includes a large number of REITs, which comprised 10.75 percent of the market value of the Russell 2000 Value Index at the beginning of January 2000. However, even without such shared constituents, the correlation coefficient between the NAREIT Equity REIT Index and the Russell 2000 Growth Index over the April 1990 – March 1995 period still was 0.6, although it declined appreciably to 0.38 over the past five years. Over these same periods, the highest consistent correlation coefficients for REITs were found with the Wilshire 5000, S&P BARRA 500 Value and the Lehman Brothers Domestic High Yield Corporate Bond Indexes.

When comparing correlation coefficients in the two periods, the relationship between the NAREIT Equity REIT Index and twelve of the other benchmarks weakened from the April 1990 - March 1995 to the April 1995 - March 2000 period. The largest changes occurred between the NAREIT Equity REIT Index and the NASDAQ 100 (from 0.56 to 0.12), the NASDAQ Composite (from 0.63 to 0.24) and the S&P Technology (from 0.46 to 0.14). In general, the weaker correlations observed during the most recent 5-year period reflect the peculiar divergence of stock prices in the 1998-99 period, when REIT stock prices weakened even as broader equity indexes continued to set new records. Of course, this was particularly true for technology stock prices. With the apparent shift in market sentiment (and valuations) that has occurred in recent months, particularly with regard to the technology sector, it will be interesting to track the effects of this shift on the correlation coefficients in [Exhibit 10](#).

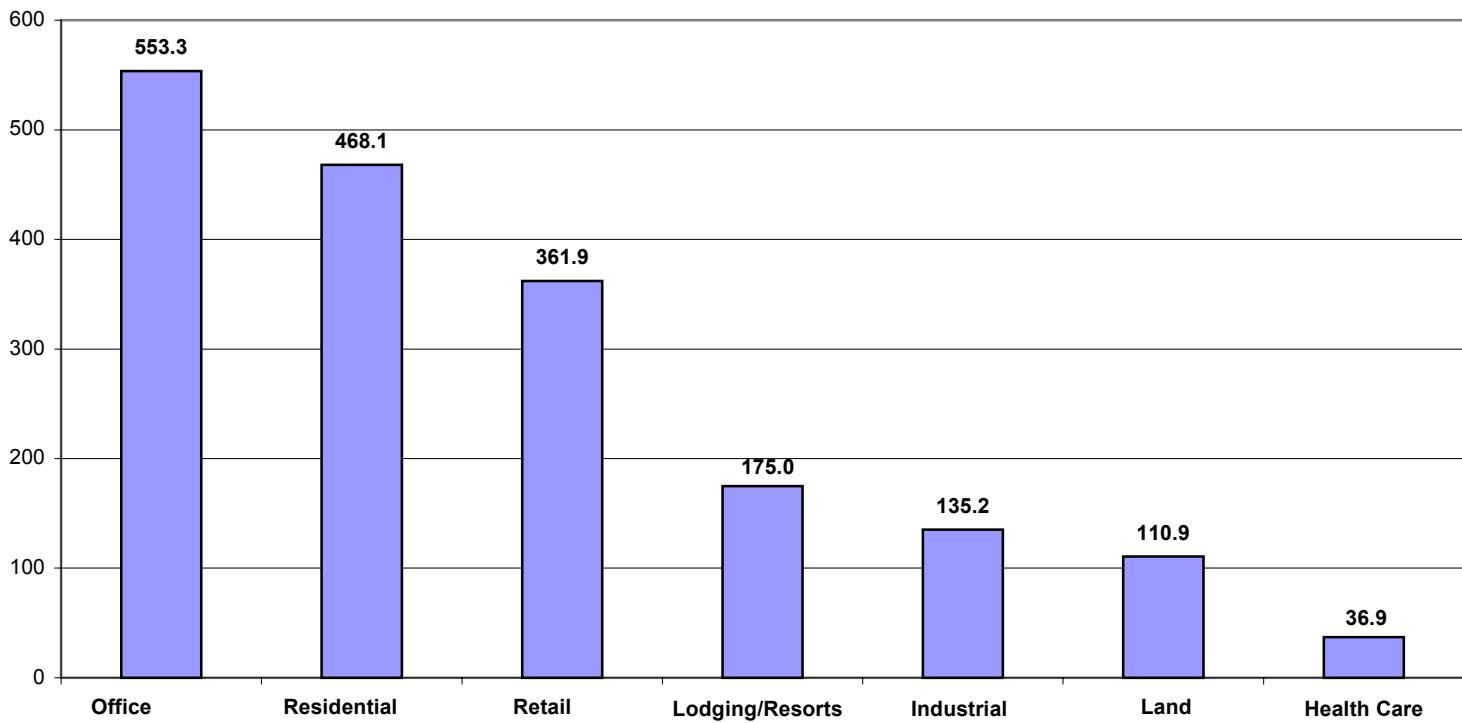
