# Hilton Floor Map



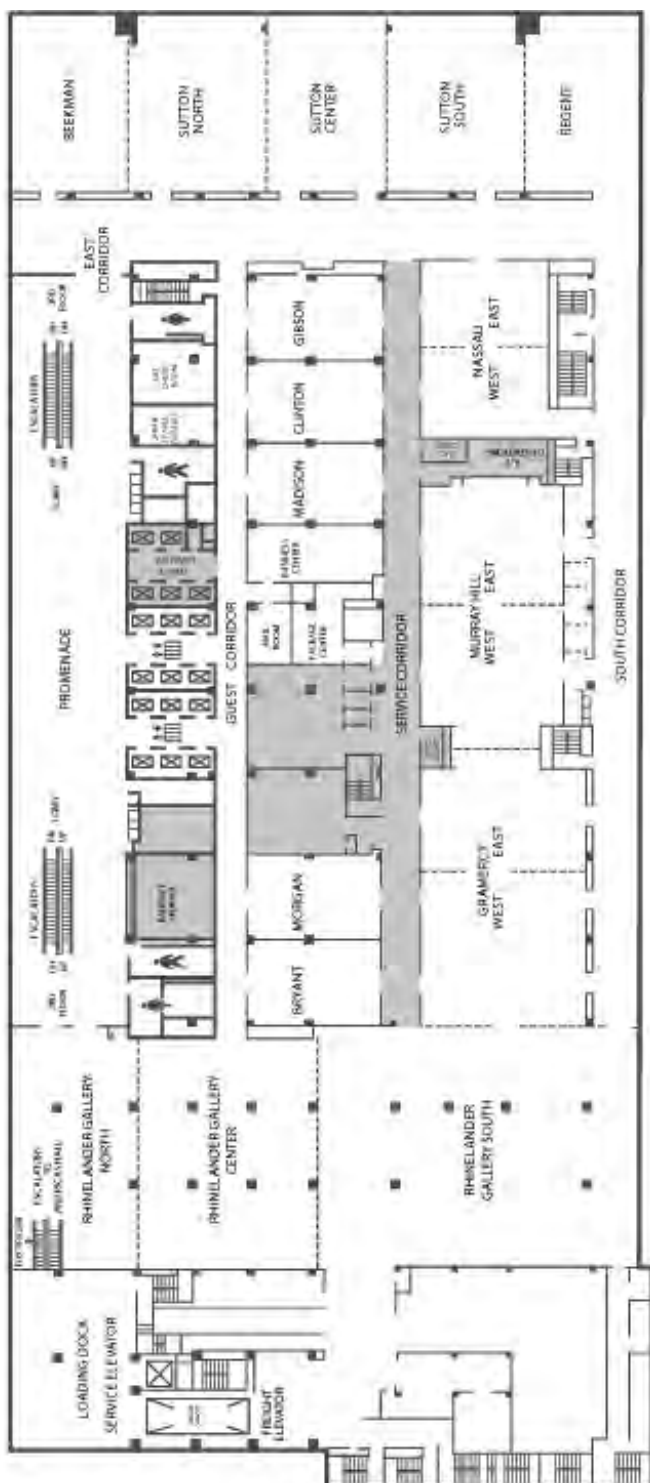

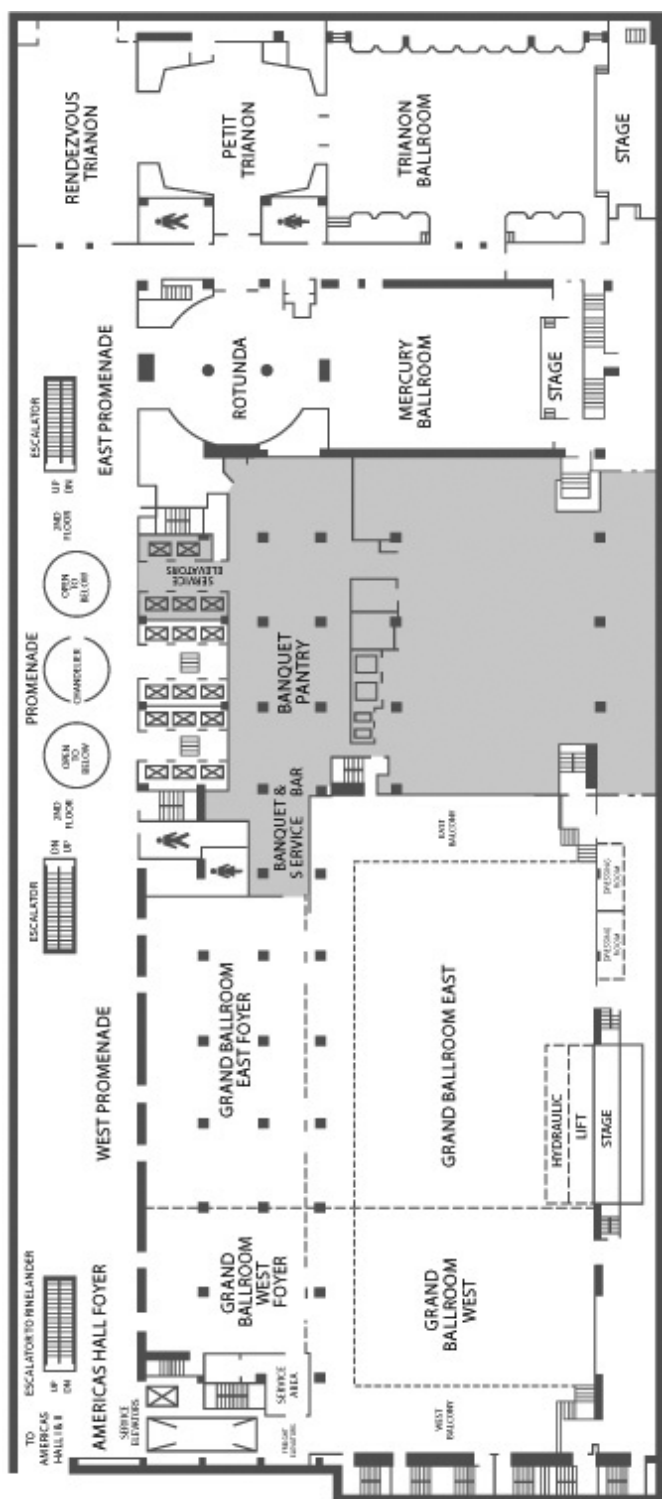
